Protecting trademarks and the community

2 concurrent priority launch periods: Sunrise
and Limited Registration Period (LRP)

Both started on July 1, 2015

Both end on August 30, 2015



The .ski Sunrise priority launch period

No increase to registry registration price

2-year minimum registration

Low application fee (non-refundable)

Open only to valid SMD-file holders



The .ski Sunrise: End-Date Sunrise

StartingDot running End-Date Sunrise for .ski

ED Sunrises the most protective of prior rights

All names registered at end of 60-day Sunrise

Auctions: if multiple requests for a name



The .ski LRP priority launch period

No increase to registry registration price

2-year minimum registration

No other costs

Reserved for key snowsports orgs and affiliates



General availability starts:

September 8, 2015
