## "Invalid" trademark record – Extra correction

In order to give Trademark Agents and Holders with a prepaid account an additional opportunity to correct the information of their "invalid" trademark records, the Trademark Clearinghouse now allows to **purchase an extra correction.** 

Through the TMCH web interface, Trademark Agents and Holders with a prepaid account will need to access the mark details page of their "invalid" trademark record and follow the below steps. Note that this process is only available until 30 days before the trademark record expiry in the TMCH.

1. Benefit from this extra correction by first clicking on an "invalid" trademark record from the "Mark Overview" page. You will be redirected to the "Mark Details" page.

Please note that:

- The status of the selected trademark record will go from "invalid" to "incorrect" to let you edit the related trademark information.
- The extra correction does not allow you to change both the mark name and mark registration number at the same time. Only one of these two fields can be changed since the extra correction is only available for previously submitted trademarks. Please make sure at least one of both fields remains unchanged.
- Once edited, the trademark record will have to be re-submitted following the instructions available in our manual (<u>here</u>). The normal verification flow will be followed. Please contact our support in case you have any questions.
- A fixed amount of 75 USD per trademark record will be deducted directly from your account after your confirmation of the different conditions stated in the pop-up message.
